#### 1. Product Characteristics

→ <u>Modular Walls</u> with Horizontal Blind (HB) and Vertical Blind (VB) are products made of MDF lamellas coated with decorative foil. Metal screws and furniture connectors are used to join the structural elements of the partitions. A single plastic pull rod enables simultaneous adjustment of all louvers.

#### 2. Material Composition

MDF slats wrapped in pre-impregnated foil; hot-melt adhesive (decorative foil bonding agent); PETG plastic pull rod; metal screws; furniture connectors

store in original, undamaged packaging, exclusively in dry and covered areas (max. temperature: 50°C; maximum humidity: 60%), in a horizontal position on flat, even surfaces to prevent bending and deformation; avoid using chemical cleaning agents

do not use chemical agents to remove dirt or stains; intended for indoor use only; protect from moisture and temperatures exceeding 50°C; when securing the product (e.g. during renovation or painting), use only standard painter's tape, which should be removed within 24 hours
